CareHere update from Savannah Smith

- Savannah Smith was providing an overview of the incentive program.

Plan Experience with Scott Haas

- April claims were up
- Loss ratio at roughly 103%. Down from 112% from last year
- Large claims:
 - o 12, list is shrinking
 - Down from 22 in recent years
- Medical claims has moderated since January
- Presciption drugs going up still
- Scott: "Optimistic at this point"
 - Possible for a break even, from an underwriting perspective.

Renewal Projectionswith Scott Haas

- Target has not changed
- Recommendations from Scott Haas:
 - Eliminate aggregate stop/loss
 - Implement CancerCare Management Plan
 - Case mangement for cancer claims
 - Nationwide network of oncologists, puts patients in touch with facilities for specialized cancer treatment, clinical trials.
 - Implement CareHere Telehealth
 - Full blown integated telehealth.
 - Do we need post-COVID19?
 - We can add at any time.
 - Kris Hursh motions to eliminate aggregate stop-loss and implement CancerCare.
 - 2nd by Anne Castren
 - Passed unanimously
- Three contribution schemes
 - 1 EE premium \$0/month
